#### LICENSING AND ROYALTY AGREEMENT

Licensor and Licensee further agree that such right and permission has been granted to Licensee on an exclusive basis for use in the Software Graphics Market.

## 3. Waiver of Approval.

Licensor releases, discharges and agrees to hold harmless, Licensee, its agents, successors or assigns, and all persons acting under its permission or authority, or those for whom it is acting, from any liability by virtue of any distortion, alteration, digitization, reconstruction, or use in composite form, whether intentional or otherwise, that may occur or be produced in the recording and subsequent reconstruction of the Content, or any other subsequent processing thereof, as well as any publication of the resulting materials.

#### 5. Warranties.

Licensor warrants that Licensor is of legal age and has every right to contract in Licensor's own name in this matter. Licensor further warrants that Licensor has the full right and authority to license the properties to Licensee as provided herein and agrees to indemnify and hold harmless Licensee from any and all expenses, suits, judgments, damages and related costs and fees arising out of Licensor's actions, omissions, negligence or otherwise under this Agreement.
